



ASRC CONTRIBUTION GUIDELINES

Arctic Slope Regional Corporation (ASRC) provides contributions and donations to a number of organizations throughout the year. ASRC's steadfast commitment to serving our Iñupiaq shareholders includes philanthropic giving that prioritizes funding for entities and initiatives that support our communities and benefit the greatest number of ASRC shareholders. ASRC makes ongoing, significant contributions to nonprofits, tribal organizations, educational institutions, and cultural entities that serve our Iñupiaq shareholders.

Donations are generally made to 501(c)3 non-profit organizations. ASRC does not fund individual people. A summary of ASRC's donation guidelines is below.

WHAT ASRC FUNDS

ASRC contributions are focused on organizations that promote the health and quality of life of our Iñupiaq shareholders and our communities. Though not an all-inclusive list, focus areas include:

- Education and youth programs
- Language and cultural preservation
- Healthy communities
- Food security

ASRC DOES NOT FUND

- Financial support to individuals
- Financial support to organizations on behalf of an individual
- Activities or services typically provided by the government
- Medical Travel and Funeral Assistance*

ELIGIBILITY

To be eligible for contributions and donations, the request should address a specific need that supports our communities and provides benefits to the greatest number of ASRC shareholders.

Written requests should be submitted at least one month before funds are needed and include the following information:

- Name and brief description of the organization
- Organization's tax ID number
- Contact information such as name, address, phone number and email
- Amount of the request (donations are typically limited to \$5,000)
- Explanation of need and how funds will be utilized (community benefit)
- How funds will be raised from other sources
